WHEREAS The Client agrees to contract The Society's services as an Interventionist to The Client for the benefit of

_____, a person in need of addiction recovery intervention services (Hereinafter called "The Beneficiary");

WHEREAS the Parties wish to confirm their agreement in writing and are duly authorized and have the capacity to enter into and execute this Agreement;

NOW THEREFORE, the Parties hereto agree as follows:

CONSIDERATON

1. In consideration of _____ per day The Society will provide full time intervention services to The Client and The Client agrees to pay the above mentioned amount for each day The Society provides such services;



2. A deposit payable to The Society or its authorized agent in the amount of _____ is payable upon execution of this agreement;
3. The Client agrees to pay The Society upon demand all costs associated with intervention treatment of The Beneficiary, including any damages caused by The Beneficiary, The Client, or guests during the provision of intervention treatment;

DUTIES AND SERVICES

4. The Society will provide supervised room and board for The Beneficiary, along with the daily services of a qualified counsellor, and the daily services of a qualified nurse;

LIABILITY WAIVER

5. The Client shall indemnify and save harmless The Society from and against any and all liabilities, loss, costs, damages and expenses of whatsoever nature or kind sustained by The Client;
6. The Client waives and releases The Society from any liability in connection with the use by The Client, The Beneficiary, guests, or sub-contractors of the



premises, services, equipment and facilities supplied by The Society, including but not limited to, injuries or damages caused by anything done or omitted from being done by The Society or his agents, servants, or workers or other independent contractors;

CONFIDENTIALITY

7. The Society hereby acknowledges that during the performance of this contract, parties associated may learn or receive confidential information and therefore all involved with The Society and related to this matter hereby confirm that all such information relating to the identity, circumstances, and related happenings of The Beneficiary will be kept confidential;

TERM AND TERMINATION

8. The term of this agreement is for a period of _____ or until otherwise mutually agreed upon. This agreement may be terminated by either party with _____ days notice;
9. Termination does not terminate the obligation of The Client to pay for any unpaid costs or services;
10. The confidentiality clause remains in effect by all parties to this agreement in perpetuity and is not terminated by the termination of this agreement;
